## Uses

Mar-flex's ArmorMastic200 is the most versatile heavy-bodied trowel grade coating available. This product is excellent for patching tie holes, filling in honeycombed areas in both rough and smooth masonry surfaces, and surface flaws. ArmorMastic200 remains flexible during freeze-thaw cycles, and can be applied during any season. You can patch all outside below grade wall ties with AM200.

Can be used with a variety of Mar-flex Commercial Products including ArmorSheet 600/601, ArmorCoat 361 and 363 and the full ArmorSeries line.

## Required Prep Work

All surfaces should be free from oil, grease, rust and any other debris. Remove below grade wall ties inside the basement and out. Patch all outside below grade wall ties with ArmorMastic200. Poured concrete walls must be free of voids and honeycombs. Any such areas, if present, should be covered with the AM200.

## Installation

Can be trowel or hand applied over wall ties, honeycombs or any surface flaw.
